Goal:

The goal of the French summer immersion camp is to provide experiences outside of the school environment that support and enrich the learning of the French language by promoting the use of language, strengthening language skills and having fun in French.

Where:

Outdoor locations if weather permitting: Spirit Square and public parks in Golden
Field trips can include Glacier Rafting Company. Indoor location if weather is bad:
Mount 7 Rec Plex 1310 9th St. S. or the Arena Lobby/Lounge 1410 9th St. S.

When:

Jocelyn Claire will be offering her *Everything Circus* Summer Camp in French from July 11th – 15th 10 am-3 pm

Claudine St-Cyr Premont will be offering *Petit Tournesol* Outdoor Camps in French from July 18th-22nd and from July 25th-29th 10 am – 3 pm

For who:

Children aged from 5 to 12 years old. No knowledge of French is required to participate.

Circus Camp with Jocelyn Claire

The children will learn and practice various circus and theatre skills in order to present a small show on the last day of camp. The skills thought will include: juggling, poi and staff spinning, devil sticks, diablo and clowning. The goal of the camp is to learn new skills, be creative, gain confidence and put on a show.

Outdoor Camp

The activities for children can include learning French songs, group outdoor games, nature studies, swimming at the Golden swimming pool. The Regular Program is done primarily on site but may include field trips to nearby locations such as Glacier Raft Company. A more detailed schedule will be sent 1 week prior the beginning of each week.

A typical Day

Daily in the morning, the families drop off their kids at the spirit square or at the specified location. Children should be prepared daily, bringing along with them a backpack, lunch, water, sunscreen, proper footwear, a hat, swim suit, towel, and medication if needed. Program runs from 10 am until 3 pm, with 1 hour for lunch. Children enjoy the program at the public locations and parks and take part in some activities and group games. If the weather is not permitting (thunder shower and lightning) these activities will be held in the Golden Arena lobby/lounge or Mount 7 Rec Plex facility. **The camp coordinator will call you in case the drop off and pick up location have changed.**

Instructors: There will be one group of a *maximum* of 10 participants and two instructors leading the group for each session. The instructors are fluent in both English and French. The supervisor has an up to date CPR Certification. Some students from High School and parents could also act as volunteers.

Cost: \$200 if registered before May 2016 and for members of Canadian Parents for French (proof of CPF membership is required). \$220 for non-members or if registered after the month of April.

In the event that our child is injured, ill or in need of medical attention and I am unable to be contacted, I authorize Petit Tournesol staff to seek medical attention on my behalf.

Note: We will attempt to notify the parent(s)/guardian(s) when a child is ill or needs medical attention. In the event that we cannot contact parents and we need to get immediate medical help for your child, we will take your child to the nearest emergency service.

Emergency Authorization: I hereby give permission to the medical personnel selected by the Petit Tournesol Camp staff to order X-rays, tests and treatment for my child when needed in the event I cannot be contacted to give consent. I consent to an ambulance being called to transport my child if necessary.

I understand that **no refunds will be given within 14 days before the start of the camp or after camp has started**. In the event that my child must withdraw within 14 days before the date that the camp starts due to contracting a communicable disease, I understand that I will be refunded **50% of the camp fee(s) paid**. Refunds for medical reasons will be processed only on receipt of an original signed doctor's note (fax or photocopy not accepted).

\$25 non-refundable administration fee included in the camp fee is non-refundable.

I will only contact my child **in case of an emergency**.

I allow Petit Tournesol Camp staff to take and use photos and/or video to promote the organization and its programs. The materials and copyright will remain the joint property of Petit Tournesol Camp and I waive any claim to remuneration for their use.

This waiver is binding on me, my heirs, executors and administrators.
